PUBLIC FORUM

Senator Rick Olseen gave an overview of the unallotments throughout MN stating that budget projections will not be getting better for 2010 but that the state is trying to move forward despite hardship. With the deficit being \$6.5 billion the House, Senate and Governor's office are seeing budget cuts as well as counties and cities.

Olseen applauded Mayor Buchite on his leadership of the underground transmission line project.

Mayor Buchite questioned how other cities look as far as levy and property tax increases.

Olseen responded stating that some counties and cities are budgeting as if LGA is going away therefore no longer depending on those monies as revenue. Olseen also state that there are ten (10) cities in Chisago County in which they are all seeing cuts and layoffs.

Tangen thanked Senator Olseen for his work on the watershed restoration pilot project proposed for Lent Township by LS Power.

Wisconsin and Minnesota, together with many other local and federal agencies, have committed to work together to create and implement a management plan to protect and improve the water resources in the St. Croix River Basin which include the Sunrise River and St. Croix River. The project will develop renewable, re-cycled water and fossil resources to produce steam and co-generate electricity. The electrical output is proposed to serve the needs of Minnesota, Wisconsin, and the Upper Midwest.

NEW BUSINESS

CONSIDER PURCHASE OF IMPELLERS FOR LIFT STATION #2

Lift Station #2 has had multiple call-outs because of pump failure. The impellers are so worn and chipped that they clog and are throwing the impellers off balance causing them to vibrate and wobble. It is becoming necessary to pull the pumps daily for cleaning to prevent middle of the night call-outs.

In addition to the quote from WW Goetsch Associates, Inc. (\$4,608.45), quotes were received from Aqua Logic Inc. (\$5,059.46) and Dakota Pump Incorporated (\$4,222.63). While the quote from Dakota Pump Incorporated came in lower than WW Goetsch Associates, Inc., it was recommended to pay the additional emergency fee for rush shipment and receive the new impellers in 7-10 days versus 4-6 weeks.

MOTION BY JULIK-HEINE/RIVARD TO APPROVE THE PURCHASE OF ONE CLOCKWISE IMPELLER AND ONE COUNTER CLOCKWISE IMPELLER, CASING GASKETS AND BOLT AND WASHER SETS FROM WW GOETSCH ASSOCIATES, INC. IN THE AMOUNT OF \$4,608.45, WHICH INCLUDES FREIGHT AND TAX, TO BE PAID FROM THE SEWER OPERATING SUPPLIES BUDGET (602-49450-210). MOTION CARRIED UNANIMOUSLY.

CONSIDER PAYMENT TO FLEXIBLE PIPE TOOL COMPANY FOR EMERGENCY SEWER ROD

The Public Works Department was rodding sewers at West and Ravine Streets when the rod broke. A camera was placed in the sewer prior to retrieving the rod to view the damages at which time a manhole was identified. This manhole was not documented on any of the current maps as it was an unknown manhole. It has since been added to the maps.

THE CITY COUNCIL APPROVED BY CONSENT AGENDA PAYMENT OF \$3,274.38 TO FLEXIBLE PIPE TOOL COMPANY FOR 700' OF REPLACEMENT SEWER ROD, TO BE PAID FROM THE SEWER OPERATING SUPPLIES BUDGET (602-49450-210).

Public Works Superintendent Mike Kriz informed the Council of his interest in picking up a used trailer mounted sewer jet to demo with the option of buying. The unit was a trade-in at Flexible Pipe Tool Company out of St. Joseph MN with an estimated quote of \$10,687.50 (a new unit would be more than \$50,000.00). If the jetter meets their needs they will come before the Council for authorization to purchase the jetter.

CONSIDER DEDICATION OF HERITAGE PARK SIGN

The Park and Recreation Commission will be hosting a sign dedication at the Heritage Park (Overlook) on Saturday, October 17th at 1:00 p.m. The sign was created by Mark Stelmack, a 2nd grader at Taylors Falls Elementary School with the design including a sketch of an eagle, fish and the St. Croix River. Because the PRC posted the notice as a City sponsored event, the Council is required to authorize the dedication.
